SECOND ROUND OF SEAT ALLOTMENT: NEET UG (MEDICAL / DENTAL) COUNSELLING 2018 (MBBS, BDS) (STATE OF RAJASTHAN): OFF-LINE

In continuation of earlier notification dated 14/06/2018 and 22/07/2018, it is for the information to all registered candidates seeking admission to UG Medical / Dental Course that the 2nd Round of Allotment Procedure for State Medical / Dental (U.G) seats will be held **off-line** as scheduled below:

Cut-off date for exit with forfeiture of fees Rs. 10,000/- (or Rs. 5000/- for SC/ST/OBCNCL/MBC NCL) [for Government Medical Colleges and Government Societies Colleges (Jhalawar, RajMES) / RUHS Medical College] and Rs. 1,00,000/- [for private medical colleges] (for all MBBS allotted candidates of round 1 and round 2)	16.08.2018 by 5.00 pm
Joining and completion of all other formalities including Bank guarantee, Bond etc., and deposition of fee (remaining amount) at allotted college and appearance before the Medical board at the allotted college	16.08.2018 to 18.08.2018 (9.00 AM to 5.00 PM)
Registration for mop-up round (Medical and Dental)	19.08.2018 and 20.08.2018, upto 11.45 pm
Mop-up round (Medical and Dental) at Academic Block, SMS Medical College, Jaipur	21.08.2018 & 22.08.2018, 10.00 am onwards
Reporting and Joining (Mop-up round allotted candidates) and completion of all formalities including Bank guarantee, Bond etc., and deposition of fee at allotted college and appearance before the Medical board at the allotted college	23.08.2018 to 26.08.2018 (9.00 AM to 5.00 PM)

Candidates are advised to note the following carefully:

1. Following candidates must bring demand draft of **Rs. 10,000/- (or Rs. 5000/- for SC/ST/OBC NCL/MBC NCL) [for allotment in Government Medical Colleges and Government Societies Colleges (Jhalawar, RajMES) / RUHS Medical College] and demand draft of Rs. 1,00,000/- (for allotment in Private medical colleges)** in favor of "NEET UG Admission Board 2018" at the time of Round 2 of counseling:
 - a) Fresh participants of Round 2
 - b) Candidates allotted a college in Round 1 but not reported at the allotted college
 - c) Candidates reported in Round 1 but resigned the seat
 - d) Candidates not allotted a college in Round 1 (CNA)

Candidates are advised to bring the above DDs (2 DDs) prepared from the bank as they may get any type of seat at the time of offline counseling.

Those who have already prepared the DD in favor of "Chairman, NEET UG Medical & Dental Admission/Counseling Board-2018" need not get it changed.

Note: The demand draft is not required from candidates who are willing to opt only for BDS course.

2. The candidates who did not join the allotted college in the first round of counseling OR who had resigned after joining of first round allotment will also be considered for second round of counseling.
3. As per Hon'ble supreme Court directions, candidate who has joined through admission in All India Quota seats (15%) / All Deemed University after Round 2 of NEET UG AIQ seats will not be allowed to participate in Round 2 of State Counselling. No candidate will be allowed to resign from the State Quota seats after cut-off date for exit with forfeiture of second round.
4. Candidates who have joined the allotted college in round 1 and wish to retain the same college / seat need not come to participate in round 2 physically; their existing allotted seat will be retained as such.
